RESIDENT GOLF MEMBERSHIPS ****Proof of residence required**

Unlimited Resident (\$1,925) - Residents of the Village of Oak Brook. Permits member to play anytime the course is open. \$5 surcharge fee applies in addition to the annual membership fee.

Limited Resident (\$1,505) - Residents of the Village of Oak Brook. Permits member to play Monday through Thursday. However, this membership does not include access to weekends (Friday to Sunday) or Holidays. Weekend rounds will be charged at the standard resident rate. \$5 surcharge fee applies in addition to the annual membership fee.

Limited Senior Resident (\$1,225) - An Oak Brook resident 60 years or older, may play anytime Monday through Thursday. This membership does not include access to weekends (Friday to Sunday) or Holidays. Weekend rounds will be charged at the standard resident rate. \$5 surcharge fee applies in addition to the annual membership fee.

Limited Junior Resident Range & Play (\$1,050) - Any Oak Brook resident under the age of 21 may play without additional green fees anytime Monday thru Thursday. (No Weekends or Holidays). Junior membership includes unlimited driving range usage. \$5 surcharge fee applies in addition to the annual membership fee.

Unlimited Corporate (\$2,200) - Any individual whose business is within the Village of Oak Brook. Permits member to play anytime the course is open. \$5 surcharge fee applies in addition to the annual membership fee.

NON-RESIDENT GOLF MEMBERSHIPS

Unlimited Non-Resident(\$2,750) - Permits non-resident member to play anytime the course is open. \$5 surcharge fee applies in addition to the annual membership fee.

Limited Non-Resident (\$2,150) - Any limited non-resident may play Monday through Thursday. However, this membership does not include access to weekends (Friday to Sunday) or Holidays. Weekend rounds will be charged at the standard rate. \$5 surcharge fee applies in addition to the annual membership fee.

Limited Senior Non-Resident(\$1,750) - Any non-resident Senior 60 years or older, may play Monday through Thursday. However, this membership does not include access to weekends (Friday to Sunday) or Holidays. Weekend rounds will be charged at the standard rate. \$5 surcharge fee applies in addition to the annual membership fee.

Limited Junior Non-Resident Range & Play Membership (\$1,500) - Available for anyone under the age of 21. Junior members may play golf anytime Monday thru Thursday. (No Weekends/Holidays) Membership includes unlimited driving range use. \$5 surcharge fee applies in addition to the annual membership fee.

DRIVING RANGE MEMBERSHIPS

Entitles member ONLY to unlimited practice balls to the north tee of the driving range and use of the north chipping green. Driving Range Membership begins when the driving range opens in March, weather dependent, and ends November 1, 2026.

Members will be held to standard course policy for no-show tee times with the following exception: A Member tee time will be charged the \$5 surcharge if booking Member does not use their tee time, all other no-shows booked by the member will be at the applicable rate (3) To pay the Sports Core for all purchases made and credit obtained by any person included on this membership; (4) To notify the Sports Core promptly in writing of loss of membership card(s) or any changes in address or telephone number. I understand that an interest fee of one and five-tenths percent (1.5%) (18% annual rate) will be charged to my balance if it is not paid within thirty (30) days of the statement date, and that my membership privileges will be suspended by the Sports Core or its agents if the charges are not paid within forty-five (45) days of the statement date. I further understand that if my account is sixty (60) days past due, my membership status will be terminated. Challenges to charges must be made within forty-five (45) days of the statement date. 5) An active credit card MUST be on file for any active membership. 6) I hereby grant permission to the Village of Oak Brook to use photographs of individuals listed on this application and hereby release the Village of Oak Brook and its trustees, officers, employees and legal representatives and assigns from any and all claims, actions and liability relating to its use of said photographs. 7) A junior membership shall be entitled to charging privileges only if a parent or legal guardian co-signs the application and agrees to comply with the above conditions. 8) Range Members have access to the MEMBER'S ONLY section of the north driving range during the season, March through October. Driving Range Members can not bring guests to the north private driving range. \$5 fee for lost/replacement ID card. Range cards and codes will not be distributed to range members. Transportation to the north tee will be provided by our "Range Shuttle". Range membership will be revoked immediately upon the discovery of the distribution of member's practice balls to a non-member.
